

## Memorandum of Understanding

This Memorandum of Understanding is made between Federal State Budgetary Educational Institution of Higher Education "Academician Ye.A. Vagner Perm State Medical University" of the Ministry of Healthcare of the Russian Federation (hereinafter referred to as PSMU) and Shiraz University of Medical Sciences (hereinafter referred to as SUMS).

### PREAMBLE

In order to establish cooperation in the field of medical education and science, PSMU, represented by acting rector Blagonravova Anna Sergeevna, and SUMS, represented by Chancellor, Professor Seyed Vahid Hosseini, agree to sign the Memorandum of Understanding.

### 1. Goals and Objectives of the Memorandum

The goal of the Memorandum is a comprehensive study of the fundamental and clinical medicine in the following formats:

- ✓ joint conferences (online and offline),
- ✓ conducting joint scientific and clinical observations, scientific, practical and educational events, organizing master classes, joint publications,
- ✓ development of student exchanges (clinical and scientific internships, summer practices, summer and winter schools in medicine, student trips with a medical component),
- ✓ professors exchanging programs,
- ✓ exchange of information on scientific achievements and innovative technologies, their implementation in practical medicine,
- ✓ collaboration between student scientific societies.

### 2. Mutual Obligations of the Parties

2.1. Implementation of this Memorandum is governed by the laws of each Party. The Parties are responsible for obtaining the necessary internal and other permits in accordance with the laws of both Parties.

2.2. Exchange activities related to joint research should be planned separately, taking into account the resources and conditions of each Party.

2.3. The rules and procedures of exchange programs are determined by a separate protocol between the Parties.

2.4. If the results of research in the course of joint projects under this Memorandum affect the issues of intellectual property rights, Parties sign an additional protocol, regulating the conditions for approach to intellectual property rights before the start of the joint project.

### 3. Duration and Termination of the Memorandum

3.1. Memorandum is drawn up in two copies in English.

3.2. Memorandum comes into force from the moment of its signing by Parties and is valid for 3 (three) years.

3.3. Memorandum may be terminated unilaterally. Party will declare its intentions to the



other Party at least two weeks before its termination, if the Party wishes to terminate the Memorandum.

#### 4. Other terms

4.1. Memorandum does not provide for mutual financial obligations of the Parties. To implement the tasks, outlined in the Memorandum, Parties seek and use financial support from international and national institutions and other organizations, both public and private.

4.2. All the changes and additions to the Memorandum are valid only if they are made in writing and signed by both Parties.

4.3. Memorandum does not impose certain obligations on the Parties. Parties shall implement the Memorandum on a voluntary basis, as necessary and in accordance with their capabilities.

#### 5. Responsibility of the Parties

5.1. Parties are released from their obligations under this Memorandum in the event of force majeure circumstances that make it impossible to fully or partially fulfill the Memorandum (force majeure, hostilities, natural disasters, etc.).

5.2. Each Party shall immediately inform the other Party of the force majeure and documents it.

5.3. Force majeure entails the suspension of the Memorandum until its termination.
