#### Brief Description of Institution

Shiraz University of Medical Sciences (SUMS) was established in 1946 as a Higher Health Education Center in Shiraz, Iran. Ever since, it has grown to become the leading medical university in southern Iran and a key center for liver transplantation, clinical microbiology, clinical immunology, and advanced electronic learning. With over 35,000 staff, 900 faculty members, 9,000 students, 18 schools, 40 hospitals (14 of which are teaching hospitals), 60 research centers, and 6 incubators, SUMS oversees the health sector in the Fars province of southwestern Iran.

Enjoying a well-developed infrastructure, distinguished faculty and expert staff, SUMS focuses its mission on educating future healthcare professionals, advancing knowledge through growth and innovation, and addressing healthcare needs in the region and beyond. Additionally, the University strives to reduce healthcare disparities, support underserved populations, and contribute to the economic development of local communities.
