

## MEMORANDUM OF UNDERSTANDING BETWEEN OFFICE OF INTERNATIONAL AFFAIRS, WONKWANG UNIVERSITY AND

- A. The Office of International Affairs, Wonkwang University and The Office of Vice-Chancellor for Global Strategies and International Affairs, Shiraz University of Medical Sciences, with the aim of fostering cooperation through both educational and academic exchanges, hereby affirm their intent to promote such exchanges that will mutually benefit their respective institutions. Educational and academic exchanges shall include, but are not limited to:
  - 1. Development of mutually beneficial academic programs and courses;
  - 2. Exchange of academic staff for purposes of teaching and research;
  - 3. Reciprocal assistance for visiting experts, and students;
  - 4. Coordination and implementation of activities such as joint research, lectures, and training;
  - 5. Exchange of documentation and research materials in fields of mutual interest, provided there are no legal or regulatory barriers;
- B. Details regarding the implementation of any specific activity resulting from this Memorandum of Understanding shall be negotiated between the two institutions as the need arises and outlined in a Supplementary Agreement. The execution of such Supplementary Agreements shall be contingent upon the availability of adequate funding within the respective institutions.
- C. This Memorandum of Understanding reflects the commitment of both institutions to educational and academic exchanges as of the date of signing. It may be amended or terminated by either party, provided that written notice of such amendment or termination is delivered to the other party at least thirty (30) days prior to the intended effective date. Any amendments or terminations shall not affect ongoing arrangements established under Supplementary Agreements arising from this Memorandum of Understanding.
